Grant Guidelines Grants are awarded twice a year. The grant application process is fairly simple and is initiated by submitting a grant application using the Common Grant Application Web site. Specific advice about the types of grants that we will or will not fund and our deadlines is available below.

Grant Guidelines — The Lawrence Foundation

The twelve-month period starts on the date of the last grant payment if approved or the date the last grant was declined. Applications from an organization that has received a multi-year grant from the Foundation until twelve months after all payments of that grant have been made.

Grant Guidelines - The Cullen Foundation

Be the homeowner and occupy the house. Be unable to obtain affordable credit elsewhere. Have a family income below 50 percent of the area median income . For grants, be age 62 or older and not be able to repay a repair loan.

Are there any timing requirements? Grant events must not be held sooner than eight weeks after the application deadline. This ensures that MHC has enough time to adjudicate the grant and successful applicants have enough time to get the project off the ground after notification. This timing requirement is firm.
