VARA was the first federal copyright legislation to grant protection to moral rights. Most visual artists are considered "self-employed" in regard to filing their taxes. In a legal and taxpaying sense this means that your "business" as an artist and you as an individual taxpayer are one and the same. There is no legal separation, such as one would have in a corporation, partnership, LLC or other legal entity.

Qualifying visual artists will be able to take that 20% deduction in addition to deducting business expenses and the standard (or itemized) deduction, raised to \$12,000 deduction for individuals or \$24,000 for married couples under the new tax plan, tax professionals say.

A variety of copyright laws are specific to artwork, as artwork provides some considerations unique to other copyrighted materials. In particular, artwork is subject to the Visual Artists Rights Act, the first sale doctrine and specific resale rights which vary by location.

But many artists also make money through licensing, allowing their images to be reproduced by other people or entities in exchange for royalty payments. In many cases, this allows artists to have a stream of income without requiring them to continue producing new original works. Not all royalty deals are created equally, however.

Under the Visual Artists Rights Act an artist can take his or her name off a work that's been modified in a way that's "prejudicial" to the artist's reputation. But as dealer Marc Jancou discovered, without an artist's name attached, an artwork can lose all value overnight.

The law gives artists certain rights in their creations. William Fisher, "Theories of Intellectual Property," in Stephen Munzer, ed.,New Essays in the Legal and Political Theory of Property (Cambridge University Press, 2001) is recommended for those who want to explore a sophisticated introduction to why the law recognizes property interests in intellectual products.

The Artist's Rights - Harvard Law School

An artist cannot decide where or to whom a painting is resold. However, artists do have the right of attribution under VARA, which allows them to claim or deny that he or she is the creator. If the creator doesn't like where the work is being shown, the artists can keep the seller from using his or her name in relation to the work.
